## Dates

Due to the accumulating snow on October 20<sup>th</sup> and 22<sup>nd</sup> the final layer of pavement and remaining seeding and sodding will be postponed until the spring of 2021.

Planned work for the week of October 26<sup>th</sup> to October 30<sup>th</sup> is:

- Paving remaining driveways on of the project.
- Installing mailboxes, street signs, and 911 signs.
- Driveway ends at the street that were previously paved will be milled to create a 3' taper to avoid snow plow damage. The driveways will be cut vertical in the spring to match with the final layer of pavement placed on the street.
- Miscellaneous clean up throughout the project. If there is debris or items needing to be removed adjacent to your property, please notify project contacts.

Private utility company (gas, electric, and communications) relocation planned is:

- None planned.

## Service Connections

- **Residents on Chestnut Drive, Camwood Trail, and the north side of Highland Scenic Road may connect and activate their private service connections to the City water and sewer systems.**
- **Residents on other streets cannot connect to the water and sewer systems at this time. Testing must be passed for other areas to be able to connect to the city water and sewer systems. We will provide updates when further areas are able to connect.**

The Contractor has planned working hours of 7:00 a.m. to 7:00 p.m. Monday thru Friday.

The Contractor will work with the postmaster and garbage haulers to establish temporary locations during construction. You will be contacted in the future regarding location and timing for these services during construction. **Please have your garbage containers at the end of your driveways the night before your scheduled garbage pick-up. This will help the Contractor get the containers to the temporary locations.**

Access will be maintained for emergency vehicles.

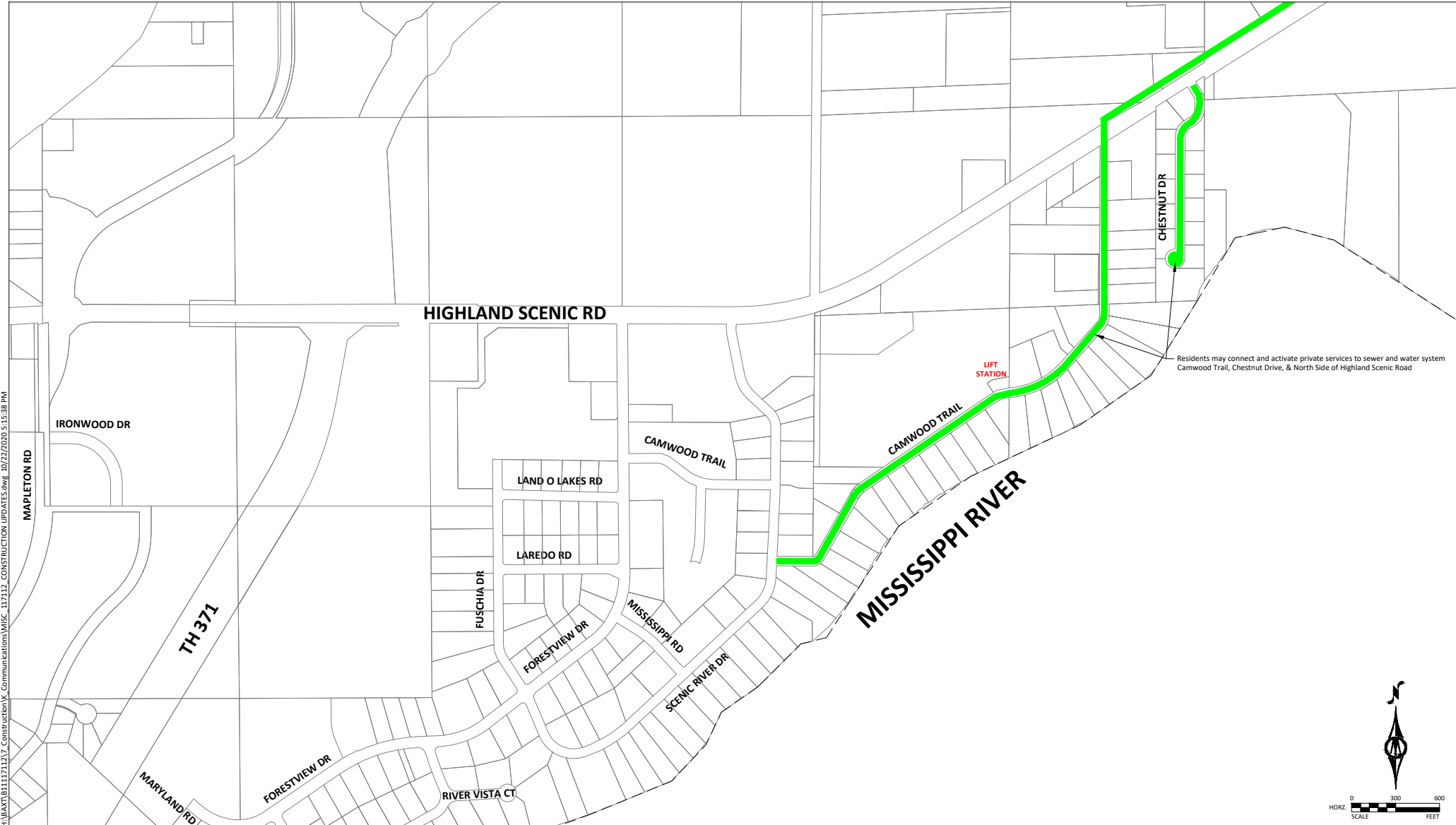
