WHEREAS, Minnesota State Statutes requires that cities review and revise their Comprehensive Plans for consistency with Metropolitan Council policy plans;

WHEREAS, in August and October of 2018, the Planning Commission held work sessions to discuss the update as they related to land use and housing; and

WHEREAS, in September of 2018, staff held a Public Open House to discuss similar issues with the public; and

WHEREAS, because of the hard work done on the 2030 Comprehensive Plan, Downtown Master Plan in 2012, and the Southwest Chaska Plan completed in 2013 and subsequently adopted in 2016 by the MetCouncil, the 2040 Comprehensive Plan differs very little; and

WHEREAS, it extends many of the goals from the 2030 Plan and SW Chaska Plan and creates policies that get to those goals; and

WHEREAS, in November 2018, the City Council adopted a resolution (Res No. 2018-138) approving the 2040 Comprehensive Plan Update and authorized its release for adjacent communities' review; and

WHEREAS, since that time the City has had their 6-month review period, which ended on May 31, 2019; and

WHEREAS, the City Council held a public hearing to approve the 2040 Comprehensive Plan at their June 17, 2019 meeting and approve the submittal for MetCouncil review; and

WHEREAS, MetCouncil has since approved the final plan at their August 12th, 2020 meeting; and

WHEREAS, the next and final step in the process is for the City to formally adopt the plan; and

NOW, THEREFORE, BE IT RESOLVED, that the City of Chaska adopts the 2040 Comprehensive Plan.

A Resolution approving SW Chaska Growth & Development Plan (amending portions of the 2030 Comprehensive Plan)							

WHEREAS, Minnesota State Statutes requires that cities review and revise their Comprehensive Plans for consistency with Metropolitan Council policy plans;

WHEREAS, the City initially identified the need for a SW Chaska growth and development plan when the 2030 Comprehensive Plan was updated in 2010; and the 2030 Comprehensive Plan contains a specific policy stating that the City should prepare an area-wide plan for the SW growth area that updates the 2003 Heights of Chaska plan and encompasses the entire growth area lying on both sides of the new Hwy 212 corridor; and

WHEREAS, this plan is intended to provide an implementable and flexible roadmap for the entire SW growth area; and due to the inextricable link between the City's downtown revitalization plans and future growth in the adjacent SW growth area, it is critical that the SW Chaska growth & development plan complement and strengthen downtown Chaska as the heart of the community; and

WHEREAS, three opportunities for general community input were provided during the project:

- Community Listening Session in June 2012;
- Community Open House in November 2012;
- Public Hearing in January 2013; and

WHEREAS, the study area encompasses a substantial number of property owners, the project team met with property owners almost monthly during the project; and the project team held seven (7) meetings with those property owners; and

WHEREAS, the project team held three (3) joint work sessions with City Council, Planning Commission and Park Board; and

WHEREAS, the Planning Commission held a public hearing on this plan at their January 9, 2013, meeting; and

WHEREAS, the Planning Commission at that same meeting recommended to the City Council adoption of the SW Chaska Growth & Development Plan; and

NOW, THEREFORE, BE IT RESOLVED, that the City of Chaska approves the submittal of the SW Chaska Growth & Development Plan (Comprehensive Plan amendment) to adjacent affected governmental units and the Metropolitan Council for review and comment.
