Overview

Work on the market structure has continued over the winter and the contractor is closing in on completion. With the promising changing of weather, site work will be resuming in the coming days.

The Union Avenue Mill and Overlay project will be starting soon. Communication related to that project will be provided separately but access to the parking lot will be maintained.



Construction Updates

- Concrete work will begin once the frost is out of the ground and temperatures allow for proper concrete curing.
- Additional construction activities will be necessary in the coming weeks to prepare the areas behind the curb for plantings. Some parking stalls will be temporarily closed to accommodate equipment and workers.
- Work on the market structure and south half of the project will continue to take place within the fenced in area.
- A final course of asphalt is planned to be placed this spring. The parking lot will be closed again for a brief period to accommodate the final construction at that time. Furter communication will be provided prior to this closure.



Frequently asked Questions

- The paint colors of the Market Structure were always supposed to be chosen by the city during construction. The red color on the sign was a placeholder chosen by the architect.
- The existing parking stall layout meet standards for a high turn over parking lot. The city and Bolton and Menk are considering adjusting the widths due to public comment. The final layout will be painted after the final lift of asphalt is placed.
- There is another set of entrances and exits meant for two-way traffic on the south side of the parking lot similar to the pre-construction layout. These are within the fence for construction activity but will be available in the final project.
