\$ SPECIAL ASSESSMENTS

The final interest rate for the Special Assessments has been determined. Payments can be made without interest until July 31, 2023. Payments can be made with interest between August 1 and November 15, 2023 before going on property taxes. The interest rate is 5.71%. PROJECT SCHEDULE

The following is an overview of the upcoming phases of the project schedule. Phases 3 and 4 from the April Newsletter have swapped in the phasing schedule, making the north block of 16th Avenue North the upcoming Phase 3 which will start on May 31st with reclaiming of the existing pavement. A phasing map is provided on the last page of this newsletter.

Week of May 29th

- No work on Monday, May 29th for Memorial Day.
- The first layer of asphalt will be paved on Phase 1.
- Utility construction will continue on Phase 2.
- Construction will start on 16th Avenue N. from 2nd St N. to 3rd St N. (Phase 3) with pavement removals.

June

- Restoration work will begin on Phase 1 including concrete sidewalks, topsoil, and sod.
- Construction will continue on Phase 2 with roadway grading, concrete curbing, and asphalt paving.
- Utility construction will begin on Phase 3.
- Construction will start on 14th Avenue N. from Mainstreet to 1st St N. (Phase 4) later in the month.
