### \$ SPECIAL ASSESSMENTS

The final interest rate for the Special Assessments has been determined. Payments can be made without interest until July 31, 2023. Payments can be made with interest between August 1 and November 15, 2023 before going on property taxes. The interest rate is 5.71%. #### **PROJECT SCHEDULE**

The following is an overview of the upcoming phases of the project schedule. A phasing map is provided on the back of this newsletter.

#### Week of June 26th

- Restoration work will continue in Phase 1.
- Concrete sidewalks will be poured in Phase 2.
- Road grading will begin on Phase 3.
- Utility work will continue in Phase 4 and may be completed by the end of the week.
- Construction will start on 15<sup>th</sup> Avenue N from Mainstreet to 2<sup>nd</sup> St N (Phase 5) with temporary water installation and reclaiming (grinding up) the existing pavement on June 28<sup>th</sup>.

#### July

- No major work to occur on Monday, July 3<sup>rd</sup> or Tuesday, July 4<sup>th</sup> for Independence Day.
- Turf will be restored in Phase 1 with sod.
- Restoration work will begin on Phase 2.
- Curb will be poured in Phase 3 in early July and the first layer of asphalt will be paved soon after.
- Road grading will begin on Phase 4 in early July.
- Utility work will begin on Phase 5 in early July.
- Construction will begin on 12<sup>th</sup> Avenue N from Mainstreet to 1<sup>st</sup> St N (Phase 6) later in July.
