\$ SPECIAL ASSESSMENTS

The final interest rate for the Special Assessments has been determined. Payments can be made without interest until July 31, 2023. Payments can be made with interest between August 1 and November 15, 2023 before going on property taxes. The interest rate is 5.71%. PROJECT SCHEDULE

The following is an overview of the upcoming phases of the project schedule. A phasing map is provided on the back of this newsletter.

Week of July 24th

- Restoration work will continue in Phase 2.
- Restoration work will begin in Phase 3.
- The first layer of asphalt will be paved on Phase 4.
- Utility work will continue in Phase 5 between 1st St N and 2nd St N.
- Construction will start on 12th Avenue N from Mainstreet to 1st St N (Phase 6) with temporary water installation and reclaiming (grinding up) the existing pavement on July 26th.

August

- Turf will be restored in Phases 2 and 3 with sod.
- Sidewalks will be poured and restoration work will begin in Phase 4.
- Road grading will begin in Phase 5 with curb installation and the first layer of paving to occur later in August.
- Utility work will begin on Phase 6 in early August and will be completed by the end of August, at which time street work will begin.
