SPECIAL ASSESSMENTS

The final interest rate for the Special Assessments has been determined to be 5.773%. Payments can be made without interest until July 31, 2025. Payments can be made with interest between August 1 and November 1, 2025, before going on property taxes to be paid over 15 years with interest. PROJECT SCHEDULE

The following is an overview of the work to be completed yet in current phases as well as tentative future forecasted schedule on upcoming phases. A phasing map is provided at the end of this newsletter. Schedules are tentative and subject to change.

Early-Mid July

- Sidewalks, steps, and retaining wall work wraps up on Phase 1A. Topsoil and turf restoration to follow
- First layer of asphalt to be paved on Phase 1B. Sidewalk grading and placement to follow
- Utility work will wrap up on Phase 1C. Roadway grading to follow.
- Construction scheduled to begin on Phase 1D the week of 7/14/25 with pavement removals & temporary water system set up.

Later in July

- Turf restoration to occur on Phase 1A
- Sidewalks to be poured on Phase 1B
- Concrete curb placement and first layer of asphalt to be paved on Phase 1C
- Utility work will be on-going on Phase 1D
- Due to the excavation depths of the sanitary sewer replacement on Phase 1D, the roadway will need to be fully closed during the installation. Timing and further details to be provided to affected residents.
