Re: 2020 Pavement Rehabilitation Project City of Jordan, Minnesota

Dear Property Owner:

The City of Jordan is planning road work on the street in front of your property during the summer of 2020. A map of the project area is included on the back of this letter. This letter is simply intended to inform you of the upcoming project, provide contact information should you have additional questions at this time, and distribute a questionnaire for early resident input. The City will be reviewing the existing site conditions and confirming the scope of the project over the coming months. During this time, you may see individuals in the street collecting pavement and soils samples or Bolton & Menk staff using survey equipment or conducting drone flights to collect data on the existing infrastructure conditions.

The project scope is limited to resurfacing of the street pavement, replacement of concrete pedestrian ramps for compliance with the Americans with Disabilities Act (ADA), and partial replacement of broken concrete curb/gutter panels. Residents are asked to provide input on the attached questionnaire to enable the City to confirm the project scope of work. With the information from the questionnaire, the City may consider additional improvements if they are found to be cost effective to implement with the street maintenance work.

We respectfully request residents return the attached questionnaire to City Hall or to <u>mikewa@bolton-menk.com</u> by December 13<sup>th</sup>. Additional information will be provided in the Spring regarding the anticipated project schedule and what residents can expect during construction.
