Overview

The City of Jordan is undertaking a construction project to construct a new 8' wide bituminous (asphalt/blacktop) trail along 190th Street from CR9 to Beaumont Avenue this summer. Completion of this trail connection is a long-desired goal of the community as it will more directly and safely connect pedestrians and bicyclists with County Road 9 and the rest of the community. Funding for the project is largely from external contributions, including a grant received from the Shakopee Mdewakanton Sioux Community (SMSC) and funding from developers who have built along 190th Street in years past.

The project includes private utility relocation, minor storm sewer and drainage improvements, site grading, addition of curb and gutter to portions of 190th Street, street patching, trail paving, ADA Improvements, and turf restoration.



Project Timeline

Favorable bids for the work were received on May 7, 2020 and the project was awarded to S.M. Hentges & Sons, Inc. from Jordan, Minnesota on June 1, 2020.

S.M. Hentges & Sons, Inc. is currently scheduled to begin work the week of June 13th. Most work is expected to be completed by late August. Some miscellaneous cleanup and items may span into the early fall.

The approximate project schedule provided to the City is below. Please note that this schedule is weather dependent, and the contractor's schedule may change. Additional notifications will be made to adjacent residents with any significant changes to the contractor's provided schedule.

Early July: Private Utility Relocation

Mid-July: Trail Construction Begins

Late July: Grading of trail, storm sewer and related drainage work, trail gravel base construction

August: Concrete Curb and Gutter along existing turn lane portions of 190th trail, street patching, and trail paving

Late August / September: Turf restoration and site cleanup

Construction

Summary of Work

Private Utility Relocation: Private utility relocation begun. This construction work is being completed by private utility owners like Comcast, Frontier, MVEC, etc. and is necessary to prepare for the new trail. This construction involves moving some buried utilities and surface boxes/pedestals out of the way of the new trail.

Storm Sewer and Drainage Improvements: Some storm structures and pipe will be added to the project, and portions of the existing ditches may be reshaped to ensure proper drainage.

Site Grading: The ground within the project area will be reshaped to accommodate the new trail alignment and maintain most of the ditches along 190th Street.

Curb and Gutter: Concrete curb and gutter will be added to the turn lanes at Lodge Drive and Beaumont Avenue to allow for the new trail to be located on the backside of the curb and gutter. The addition of curb and gutter allows the trail to be placed adjacent to the road, while protecting trees along the south side of the Timberline development.

Street Patching: Portions of 190th Street will be cut out and patched with new bituminous near the new curb and gutter.

Trail Paving: A new 8' wide multi-use bituminous trail will be paved on the north side of 190th Street from CR 9 to Beaumont Avenue.

ADA Improvements: ADA stands for Americans with Disabilities Act. Pedestrian facilities including pedestrian ramps trails and sidewalks are constructed to adhere to specified criteria.

Turf Restoration: Any disturbed turf will be restored following construction. A method called "hydro-seeding" will be used. The seed will be maintained by the contractor until acceptance.

Work Area Safety

It is very common on these types of projects that area residents (especially children) become quite curious about the work the Contractor is performing. We ask that you please be respectful of and stay well clear of construction zones. Hazards and dangers exist from heavy machinery, trenches, loose material, confined spaces, hot asphalt, etc. and often times are not recognizable by the general public. The Contractor has responsibility to ensure safety on the project and within the construction area. Any direction

from the Contractor regarding safety must be heeded. If you observe an unsafe condition please report it to **Luke Wheeler** immediately.

Access & Traffic Control

Access along 190th Street will be maintained during construction. While turn lane re-paving is occurring, and during installation of curb/gutter in those areas, some delays should be anticipated by motorists. At times, the contractor may use flaggers to maintain access along 190th Street using a single lane. Please drive slow through the work zone to keep you and the workers safe!
