

# 190th Street Improvements Project

## **Construction Newsletter 02 - June 2025**

### **OVERVIEW**

The city of Jordan is reconstructing 190th Street from County Road 9 to Beaumont Avenue during the summer of 2025. This project will replace the deteriorating pavement and prepare the corridor for future growth and development in the area. This construction aligns with the Hwy 169 / Hwy 282 / County Road 9 interchange construction which includes a roundabout at the County Road 9 / 190th Street / Valley View Drive intersection.

### PROJECT UPDATES

- \* Please note that the schedule detailed below is subject to change due to weather and contractor scheduling. Thank you for your patience and cooperation throughout construction!
- UPCOMING ROAD CLOSURE: On June 3rd, 190th Street will be closed to through traffic from CR 9 to Beaumont Avenue. 190th street will remain closed to through traffic through the the remainder of the project. The contractor will be removing the existing pavement along 190th Street from CR 9 to Beaumont Avenue on June 3rd. After pavement removal, a gravel surface will be maintained for local traffic.
  - Through traffic (including the Timberline neighborhood) will utilize the detour shown on the map on the reverse side of this newsletter.
  - Local access to residents and businesses with accesses directly off of 190th Street within the project area will be maintained via the routes detailed on the map on the reverse side. During the closure, 190th street will be maintained as a gravel surface. The roadway may be rough and narrow at times along with active construction activity. Please keep speeds low within the project area.
  - There may be excavations crossing 190th Street during the month of June which may create intermittent access restrictions from one of the highlighted local access routes. The City's on-site construction representative or contractor will notify residents and businesses of the appropriate access route during these intermittent restrictions.
- Beginning in early June, Minnesota Valley Electric Company (MVEC) will be installing new underground power along the south side of 190th Street and will remove the existing overhead power poles. This work is expected to completed by mid to late June.

# **PROJECT UPDATES (CONTINUED)**

- Roadway construction and concrete curb and gutter installation is tentatively scheduled for mid-June through early July
- Base course paving is expected to be completed around mid-July.
- The project is estimated to be completed including final wear course paving and striping around early-August.

### **COUNTY ROAD 9 ROUNDABOUT UPDATE**

- CR 9 will remain open with a single lane in each direction throughout the summer. Currently, the access to Valley View Drive from CR 9 is closed to construct the eastern half of the roundabout.
- Beginning in late June or early July and extending until late August, MnDOT will be closing the access to 190th Street from CR 9 for construction of the west half of the CR 9 / Valley View Drive / 190th Street roundabout. Motorists will continue to use the detour identified on the map below during this closure.
- CR 9 through traffic will be maintained with one lane in each direction via the newly constructed eastern half of the roundabout.
