Competitive bids for this project were received and the project was awarded to Rochester Sand & Gravel from Rochester, MN on February 13, 2023.

Schedule Update – Tree Removal

The project is moving forward! The first line of business is tree removal. The contract milestone date to complete this is March 31 and is dictated by MnDOT and the State of Minnesota (the city is receiving funds for the project from the state and we need to abide by their project requirements which includes tree removal).

The contractor intends to perform tree removal starting the week of March 20th and estimates the work to last five days. Bolton & Menk and City Staff will be on site intermittently during tree removal checking in with the contractor. Tree removals will be completed by Wabasha Tree Service.

Trees scheduled for removal will be marked ahead of March 20. The stumps will remain for now and will be removed at a later date.

*The City will plant 100 boulevard trees this fall as a part of this project.

Informational Meeting

The City and contractor will be meeting soon to review the overall schedule and discuss the project with all construction stakeholders (private utilities and others involved in the improvements). This step is important for planning and to gather pertinent information to share with this group at <u>Neighborhood Informational</u> <u>Meeting #3</u> (timing is still To Be Determined but will occur later this spring and before the rest of the project starts).
