



# 2025 STREET AND UTILITY IMPROVEMENTS

**Neighborhood Construction Meeting** 













- VALLEY PAVING, INC. has been retained to complete construction.
- Start Timeframe Mid-June, 2025
  - Work begins in Irish Court Neighborhood June 16, 2025
  - Continues roughly north, ending with 59th St in August/September
- Substantial Completion Date SEPTEMBER 12, 2025
  - All construction: Storm Sewer, Curb and First Pavement Lift, Final Lift Paving, Traffic Signs, Restoration, Punchlist Items
- Final Completion Date OCTOBER 31, 2025
  - Final Documentation





## <u>CONTRACTOR'S PRELIMINARY SCHEDULE (6/3/2025)</u> IRISH COURT

- Begin Construction: Mid June June 16, 2025
- Non-wear Paving: Early July week of June 30th

### TEAL PASS ESTATES

- Begin Construction: Early July week of June 30th
- Non-wear Paving: Late July week of July 21st
- 55TH/57TH/JULEP AND 55TH ST N (LAKE ELMO VISTA)
- Begin Construction: Late July week of July 21st
- Non-wear Paving: Mid August week of August 14th


### 59TH STREET CIRCLE N

- Begin Construction: Mid August week of August 14th
- Non-wear Paving: Early September week of September 1

- Contractor to determine removal — Planned for each neighborhood


- Will need to set up a mailbox bank.

- If removed Contractor to salvage and replace.

## **PROJECT SCOPE - RESTORATION**



- Sod is watered by Contractor first 30 days
- Do not mow sod to less than 3-4 inches
- Driveways will be impacted and be repaired with/after new curb.





# FREQUENTLY ASKED QUESTIONS

- What hours is the Contractor allowed to work?
  - 7 AM to 7 PM M-F, 8 AM to 6 PM Saturday
- Why do I have paint and flags in my yard?
  - Private utility locate markings or survey stakes used to measure during construction
  - Do not remove
- What will happen to my mailbox during construction?
  - Temporary mailbox locations are set by contractor and postmaster
  - Existing Mailbox will be removed, stored, and replaced at the end of the project
- Will I always be able to access my house?
  - Contractor has rights to dig / block roadway in construction area during working hours
  - Driveways will be blocked during work in front of home
  - Access in and out of neighborhood to be communicated as project advances
  - Concrete work will block access into driveway during cure time





# FREQUENTLY ASKED QUESTIONS

- Is there anything I need to do before construction starts?
  - Remove irrigation system, dog fence, and any plantings you want to save
  - City not responsible for repairs of systems hit within the right of way.
  - Reinstallation is at property owner's discretion
