

## Attend a public information meeting for the MAPO ADA - Transition Plan & Inventory:

The Mankato/North Mankato Area Planning Organization (MAPO) and partner agencies, including the cities of Eagle Lake, Mankato, North Mankato, Skyline, as well as Nicollet and Blue Earth counties, will host a public information meeting to provide information on efforts to complete an American with Disabilities Act (ADA) Transition Plan and Inventory. We invite you to attend the meeting to provide your input on the findings of the process and draft ADA Transition Plans available for each MAPO partner agency. Each plan documents the results of field inventories completed between October 2017 and November 2018 and provides a plan and schedule for the removal of accessibility barriers for each agency.

MAPO and partner agencies wish to provide safe and accessible infrastructure for all users and are required under the ADA and the Code of Federal Regulations to develop a plan for the removal of any barriers to accessibility in policy, practice and facilities in public rights-of-way.

### Attend the meeting to:

- Gain an understanding of plans and schedules for the removal of deficiencies identified through the Self-Evaluation process for each MAPO partner agency.
- Provide feedback on the draft ADA Transition Plan documents as the process comes to an end and the drafts are finalized.

A brief presentation will begin at 3:30 pm. An opportunity to review the draft plans for each jurisdiction and provide your comments is available through the project websites below.
