

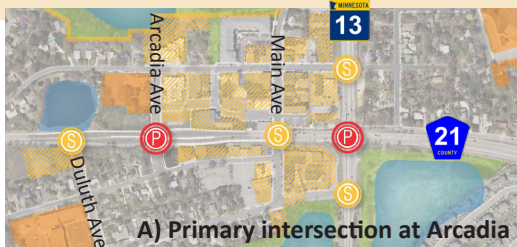


## TH 13/CH 21 Reconstruction Project

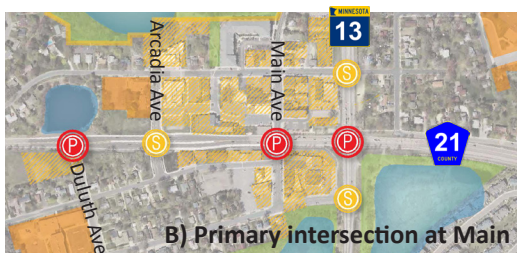
# NEWSLETTER

The four reconstruction project alternatives are available for review on the project website. Each has varying strengths and challenges when evaluated using the project goals. The basis of the four alternatives comes down to two major corridor considerations:

## 1 PRIMARY INTERSECTION AT ARCADIA OR MAIN



Corridor Access Management designates where and how vehicles enter and exit an area. The number of access points in a downtown environment needs to maintain a balance between reducing the risk of user conflicts while serving the circulation needs of local businesses and residences.



A mix of primary and secondary intersections is needed in order to reduce delay, preserve mobility, and minimize crash problems. A **primary intersection** maintains full access in all directions (signal, roundabout, all-way stop, thru-stop), while a **secondary intersection** reduces access in one or multiple directions (Thru-Stop, Right-in/-out, 3/4 Access).

## 2 TH 13/CH 21 INTERSECTION CONTROL



Traffic Signal

OR



Roundabout



The intersection control alternatives at TH 13 and CH 21 include an improved signalized intersection (additional turn lanes and signal retiming) or a multi-lane roundabout.

Evaluation of these alternatives for both current and projected future traffic volumes have been completed and will be available at the Open House.
